2021-22 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Howell Mountain Elementary School (and District Office) held a public hearing on September 8, 2021 and determined that the School had sufficient and good quality textbooks, instructional materials, and science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption. Statewide Assessments

Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;

Options

2021-22 Opportunities for Parental Involvement

During the COVID-19 pandemic, virtual parent involvement is relied upon to seek parental input, share information regarding student achievement and to virtually collaborate in publicly held meetings; such as, school site council. Parents are an integral part of school life at Howell Mountain School. When COVID-19 restrictions are modified or lifted, Howell Mountain ESD will welcome opportunities for families to resume involvement practices. Former practices to welcome families included: encouraging parents to come to school regularly for the daily morning meetings, Friday morning activities and for special events such as: monthly student recognition assemblies, classroom volunteerism, Dr. Seuss Day, Earth Day, STEM Fair, Music Recitals, the Winter Program, the Spring Talent Show, and the annual Authors' Festival.

Post-COVID-19 opportunities for parental involvement include: Back to School Night, Parent/Teacher/ Student Conferences, volunteering to drive during field trips and attending musical performances. Howell Mountain School District parents are also to become active members in our Parent/ Teacher Organization, which focuses on room parents to support each classroom. Additionally, School Site Council continues to contribute to the culture of the school.

Parents are invited to attend workshops held for them in the evenings on campus, including education engagement meetings, which are intended to encourage parent participation in school-wide decision-making. Howell Mountain School strives to include all parents in the school culture. In addition, we hold regular bilingual meetings and group support sessions for our Spanish speaking parents. An annual Title I parent meeting (bilingual) informs parents about Title I program development and implementation, reinforces the importance of standards achievement, and encourages parents to support their children, including participation in the after-school program. Parents of students with suspected or identified special needs are involved in Student Study Team conferences concerning their child in addition to annual Individual Education Plan meetings. Families are encouraged to monitor and assist their children with homework, using the annually distributed Student Planner and/or the electronic Aeries Gradebook system for grades 3-8. Parents and students also attend individual conferences scheduled each October and February to explain standards-aligned assignments, discuss student achievement and set student goals.

2021-22 School Safety Plan

Safety of students and staff is a primary concern of Howell Mountain Elementary School District. The school is in compliance with laws, rules, and regulations pertaining to hazardous materials and state earthquake standards. The School Site Safety plan is annually reviewed and updated by the School Safety Committee and school Site Council. All revisions were communicated to both classified and certificated staff. The plan was reviewed by administration and staff at the August 16, 2021 staff meeting and at the Site Council on December 14, 2021. Revisions to the plan were made and approved at the School Site Council on January 13, 2022.

The school's disaster preparedness plan includes steps for ensuring student and staff safety during a disaster. Fire, earthquake, and disaster drills are conducted on a regular basis throughout the school year. Lockdown drills are held annually. Each classroom is equipped with a portable toilet, privacy screens, bricks of water, emergency first aid kit, flashlights, blankets, and food.

There is a designated area for student drop off and pick up that keeps students separate from vehicular travel. Students are supervised before school, during breaks, and after school by classified and/or certificated staff. Entry points to the school campus are limited, and visitors are required to check-in at the main office and sign in for a "Visitor's" pass. Personnel at the school routinely review video surveillance footage.
