Resolution On The Sufficiency Of Textbooks and Instructional Materials

WHEREAS, Education Code section 60119 specifies that the governing board of Howell Mountain ESD in order to comply with the requirements of Education Code Section 60119 held a public hearing on September 17, 2024 at 6:00 pm in order to receive funds for Pupil Textbooks and Instructional Materials Incentive Program (Education Code section 60252), and/or funds for instructional materials from any State source in a fiscal year in which the Superintendent of Public Instruction determines that the base revenue limit per average daily attendance (ADA) for each school district shall increase by at least one (1%) percent from the prior fiscal year, and;

Whereas, the governing board of Howell Mountain ESD, in order to comply with Education Code 60119 held a public hearing which is on or before the eighth week of school (between the first day that students attend and the eighth week from that day- on or before October 07, 2024)

Whereas, as required by Education Code section 60119, the Governing Board has provided 10 days' notice of the public hearings or hearings required by subdivision(a) of Education Code 60119, and;

Whereas, as required by Education Code section 60119, the notice set forth the time, place, and purpose of the hearing, and the notice was posted in three public places in the school district, and;

Whereas, as required by Education Code Section 60119, the Governing Board has held a public hearing at which the Governing Board encouraged participation by parents, teachers, members of the community interested in the affairs of the school district, and bargaining unit leaders, and;

For a Finding of Sufficient Instructional Material:

Whereas, information provided at the public hearing and to the governing board at the public meeting detailed the extend to which texts and instructional materials were provided to all the students, including English Learners in the district, and;

Whereas, the definition of "sufficient textbooks or instructional materials" means that each student has a textbook or instructional materials, or both, to use in class and to take home.

Now, Therefore Be It Resolved, that after a public hearing held pursuant to Education Code section 60119, the Board of Trustees of the Howell Mountain Elementary School District hereby determines by this resolution, that each pupil, including English Learners, in Howell Mountain School has been provided sufficient textbooks or instructional materials, or both, in each subject that are consistent with the content and cycles of the curriculum framework adopted by the State Board and are aligned with the academic content standards of the State of California Department of Education in all content (subject) areas. The Superintendent is authorized to certify that the School District has complied with the requirements of Education Code section 60119 and sign the certification document.
